SCHOOL FEES PROCEDURES

1. Fee statements are issued to individual families by the end of week two of each term, by email (or mail if no email provided).
2. Payment is due in full within 14 days of issue, unless on a pre-arranged payment plan. All extensions or individual payment plan requests must be made in writing to the Finance Officer and will be responded to in writing to confirm the agreement.
3. Unpaid accounts will receive an overdue notice for payment, 7 days after the due date.
4. Families with outstanding amounts 14 days after the due date, will receive a further letter requesting payment or a formal payment arrangement with the school within 7 days.
5. Should the account remain unpaid, then all overdue accounts without a formal payment arrangement, will be considered for debt collection options.
6. Consideration will be made, to forward the account to our contracted Debt Collection Agency (George Laurens GC Pty Ltd).

PAYMENT OF FEES

Payment is due each term at the end of week 4. If you wish to pay in instalments throughout the year, then please contact the school office for a payment plan.

Payment can be made by EFTPOS at the school office and online via Bpay or Bpoint.

CONCESSIONS

Families experiencing *extreme financial hardship* may apply for a concession, which is available on Tuition Fee only (not on other levies). Application forms for concessions are available at the school office.

Concessions are not ongoing, and applications need to be resubmitted at the commencement of each school year.

Families eligible for concession are required to pay their account via Direct Debit or Centrepay.

CAPITAL LEVY

This levy contributes towards the repayment of loans and the upkeep and ongoing maintenance of buildings and structures within the school grounds.

Tax deductibility cannot be offered for compulsory levies such as the Capital Levy.

Please note: No concessions will apply to this levy.

STUDENT ACTIVITY LEVY

This levy is charged equally over four terms covering all activities undertaken by students during the year e.g. swimming, excursions, interschool sport, other curriculum programs etc.

Please note: No concessions will apply to this levy.

CAMP LEVY

This levy is to cover the cost of the Year 5 and 6 Camp. This levy is for Year Five and Six students only.

Please note: No concessions will apply to this levy.

PARENTS AND FRIENDS LEVY

The Parents and Friends Levy replaces the need for on-going fundraising and is charged equally over four terms.

IT LEVY

The IT Levy is to ensure that hardware is current; hence, the students' knowledge and use of technology is enhanced.

Please note: No concessions will apply to this levy.

VOLUNTARY BUILDING FUND AND LIBRARY FUND

Families may wish to donate to the Building Fund or Library Fund. These donations are tax deductible, and a tax receipt will be issued.

VOLUNTARY PARISH DONATION

Donations will help the Parish to build community, encourage spiritual growth and extend support to neighbours in need.

INSTRUMENTAL FEES

This only applies to students who wish to attend instrumental lessons. The fees are payable direct to the instrumental company, Creative Kidz. Further information is available from the school office.

CALCULATION OF YOUR FEES FOR 2026

To calculate your total School Fees and Levies for 2026, add together

1. The total **Fees and Family Levies** - for the number of children in your family (from the Fees and Family Levies table).
2. Each **Student's Year Level Levy** (from the Student Levies table).

Calculation for Bpay payment plans

To pay over 40 weeks – divide above total fees by 40	
To pay over 20 fortnights – divide above total fees by 20	
To pay over 10 months – divide above total fees by 10
